Volunteer Release and Hold Harmless Agreement

It is understood and agreed that all rights under the statute which provides as follows, "Certain Claims Not Affected by General Release – A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor," are hereby expressly waived.
